We have received and are now making public the report of the Independent Review of the Culture of St John's Theological College. The report is thorough, well-founded and reasoned, and is a clarion call for change.

We are deeply grateful to Miriam Dean QC and Doug Martin, together with support from Nura Taefi, for the extraordinary work, care, fairness, and clarity that this Report represents.

We also want to acknowledge with gratitude the large number of people who participated so positively in this review process and particularly those who brought forward their concerns and painful experiences. We know this has been very costly for some of you. E mihi ana ki a koutou katoa i runga i te aroha.

The Report speaks for itself. We believe that the full implementation of this Report's recommendations is critical and that such implementation needs to be subject to independent monitoring. We accept therefore the recommendation that a "small working group" be established to "monitor implementation of the plan to ensure the meaningful change required is brought about both in policy and practice." General Synod Standing Committee will be asked to immediately consider mandating this group which will then be established in consultation with all parties.

The well-being and safety of students and staff has to be our highest priority. The Report also asks that we deal as a matter of urgency with issues of governance, including conflicts-of-interest both real and perceived, proper separation of powers, and clarity about where responsibility lies. The Archbishops have agreed together with the Chairs of Te Kotahitanga, Te Kaunihera, and the St John's College Trust Board, that the recommendations of this Report must be taken seriously, and have committed to taking immediate and decisive steps to implement them.

Finally, we reiterate that we are committed to ensuring that the challenging learnings and insights contained in this Review are fully incorporated into the life of a College that has enormous inter-generational potential for good across our whole Church, to the glory of God and in the service of all people.
